17/63 County and District Cllrs' Reports

17/65 Update – Vital Earth

Cllr Woodrow reported that over the summer there had been a noticeable smell on an almost daily basis around the A52 and Derby Road. The smell was similar to previous smells from Vital Earth, however on contacting Vital Earth they informed Cllr Woodrow that had been on changes from their point of view. He will continue to report noxious smells – Cllr Hall confirmed that Cllr Woodrow has the full backing of the Parish Council to raise issues. Cllr Naylor reported that there had been sewer smell in the same area. The next meeting at Vital Earth is in October and Cllr Woodrow will attend.

17/67 Highways and Rights of Way

Update on jobs reported to Highways:

Cattle grid - the cattle grid on Ladyhole Lane has been repaired.

Airfield / Bradley Wood - The Clerk contacted Ashbourne Town Council to see if they could provide assistance in deterring motorcyclists from the airfield – their response was: Ashbourne Town Council have suggested that you write to the land owners to see if they can do anything to deter the motorbikes. We have written in the past but never seen to get a response. You could try signage like we have done in Bradley Wood. It is a difficult one as you try to stop them from coming onto land in one area they then find another as the area is large with lots of access points.

Cllr Woodrow said that he had contacted JCB security in the past but that they are based in Rocester and don't seem keen on coming over to Ashbourne. Cllrs decided that the Parish Council has done as much as it can do and will continue to monitor the situation.

Speed Indication Device -

Cllrs still don't think the sign is working properly. It was suggested that overhanging branches may be interfering in the operation of the sign.

Cllr Woodrow asked if there had been any follow up regarding the rejected application for a house on Rough Lane. Cllr Hall noted that DDDC Planning said that if the application had been to provide a home for an agricultural worker it may have been passed, as this would fit in with the requirements of the Local Plan, as there is local demand for this kind of housing. Cllr Naylor said that he had noticed that in the DDDC weekly planning bulletins that individual housing applications are being turned down, whilst applications for mass housing are usually permitted.

"Many thanks for your e-mail in connection with the above. In the absence of any comments the letter sent to all Parish Councils on or around 30th June 2017 advising them the Local Plan Main Modifications were subject to public consultation indicated as follows: "Main Modifications are proposed changes to the submitted Derbyshire Dales Local Plan that are required in order to make the Derbyshire Dales Local Plan sound and legally compliant. The content of the Main Modifications being derived from the discussions at the hearings sessions of the Examination in Public." I trust that this clarifies the situation for you. Please do not hesitate to contact me if you require any further information."
