The application was passed at the planning meeting earlier this evening. Cllr Hall and Cllr Naylor attended the meeting and spoke against the development on behalf of the parish. Cllrs were concerned about the impact on Church Lane in light of the development. It is considered likely that traffic delays on the A52 will see increased traffic on Church Lane, as drivers use it as an alternative route to / from Ashbourne. Cllrs made the point that any traffic management system must be able to incorporate farm vehicles. Cllr Hall said that environmental issues were also not addressed.
