We currently only waymark paths where it is difficult for users to the follow the Ordnance survey map, I wouldn't advise erecting yellow markers on a public bridleway, as yellow arrows indicate a public footpath, blue arrows are used on public bridleway which can be used by walkers, horse riders and also cyclists. I wouldn't normally install a waymarker post in the middle of field as they can be damaged by agricultural machinery and livestock.

07/21 Airfield Development Progress

Flooding – Cllr Millward advised the DCC Officer overseeing the site works that a temporary pipe should be put in to divert water away from the houses. A temporary pipe has now been installed from the airfield to the ditch by the bus stop, Cllr Millward said this seems to have helped. Cllr Millward says that DCC seem to be making an effort to manage things. Cllr Hall proposed that Cllr Millward should be the Parish Council contact with DCC and the developers as they are close to the site and can respond quickly. Cllrs Millward said he was happy to do it. Cllrs Wright, Moseley, Naylor and Cranstone approved and the motion was carried.



14/21 Update: work on Osmaston Estate Copse, A52

Cllrs have received several queries regarding the tree felling at the Osmaston Estate Copse. Some parishioners were unhappy at mature trees being removed and others asked if it was to do with the airfield development. Cllrs and the Clerk have been in contact with DDDC, DCC and the Estate. Neil Hogbin of Fisher German (land agents for the Estate) confirmed that the Estate had applied for a felling licence from the Forestry Commission which was granted. DDDC confirmed that there was not a Tree Preservation Order on the copse and that a condition of this scale of tree felling was replanting. The Estate and DCC confirmed that the tree felling has nothing to do with the airfield development. This was confirmed by Neil Hogbin, who also explained that the Estate would be planting more trees and creating a wood – see tree planting map below.



The map can also be viewed on the Parish Council website and Osmaston and Yeldersley Parish Noticeboards. Tree protection orders are applied by DDDC, not DCC, as they come under Planning. Cllr Hall asked Cllrs if they would like the Clerk to write to the Estate expressing support for the tree planting, as it will shield the village from A52 traffic and noise, but that the PC would have appreciated prior knowledge of the application in order to allay parishioners' concerns. Cllrs approved the proposal.
