

**Minutes of Osmaston and Yeldersley Parish Council held on  
Tuesday 21<sup>st</sup> September 2021, 7:30pm, in The Shoulder of Mutton PH, Osmaston**

**71/21 Declarations of Interest**

Cllr Millward's interest was acknowledged regarding the car parking at the Village Hall (leased by DCC for the school).

**72/21 To consider for approval - draft Minutes of the Parish Council meeting held on Tuesday 20<sup>th</sup> July 2021**

Cllr Hall asked if Cllrs approved the draft Minutes of the Parish Council meeting, held on Tuesday 20<sup>th</sup> July 2021, as a true and accurate record of the meeting. Cllr Naylor proposed approving the Minutes, this was seconded by Cllr Millward. The Minutes were signed off by the Chair, Cllr Hall.

**73/21 Election of Vice-Chair**

Cllr Naylor proposed Cllr Wright, Cllr Millward seconded, all Cllrs in favour. Cllr Wright accepted and signed the acceptance of office.

**74/21 Public Participation**

Two members of the Derbyshire Ramblers Association attended the meeting to discuss their reports on the Rights of Way in Osmaston and Yeldersley. It was agreed that the Rights of Way are accessible and well maintained with a few minor issues to be addressed. Cllr Hall thanked them for attending.

A member of the public was in attendance to raise concerns about parking in the village - earlier on 21<sup>st</sup> September an ambulance was unable to get through the village due to the numbers of vehicles parked on the road and on pavements. The resident also complained about cars parking across their driveway forcing them to pull out blind into oncoming traffic. The Clerk has been in contact with the Police to flag the Parish Council's concerns re parking. The police have asked that the Parish Council and residents report their concerns via the 101 non-emergency number.
