The Clerk said that money will need to be moved across from the Reserve account to cover expenditure for the rest of the financial year 2022 – 2023 and ensure that the bank account is in the black for the start of the next financial year. Cllr Hall proposed transferring £600.00 across, subject to a check on the PC financial regulations. Cllr Moseley seconded. All Cllrs agreed.
